## 10.0 Member Reports on Community Issues Related to Fairhaven

Fairhaven has started to receive information from the Ministry of Long Term Care, regarding the roll out of vaccination against COVID-19. The long-term care sector continues to be the government's top priority for vaccine distribution. We are preparing for the vaccine administration to start the first week in February. The vaccine will be administered on-stie with the assistance of staff from PRHC. Consent forms have been mailed out to families.

Councillor Sherry Senis will be putting forward a motion at the Council meeting for the Township of Selwyn, and at the Peterborough County Council on the deployment of rapid COVID testing in long term care (LTC) facilities and vaccinating all LTC residents by February 15, 2021. That the Province restore mandatory inspections for LTC homes, that the Federal government provide sufficient emergency funds to hire adequate staff and that the province strike an emergency rapid response task force to review all LTC complaints.
