The Registered Nurse (RN) is part of an interdisciplinary team and is accountable to the Resident Care Manager. The RN facilitates a collaborative working environment by means of proven leadership, teamwork, innovation, and best practices for nursing and resident care services. These responsibilities shall be carried out in accordance with Fairhaven's mission, vision, values, leadership philosophy, policies and procedures and applicable legislation and regulations.

RESPONSIBILITIES

- Maintain a resident-centered approach in assessment, planning, provision and evaluation of resident care.
- Applies current knowledge regarding resident needs, principles of gerontology, nursing care and general health maintenance and promotion.
- Direct and supervise the work of Registered Practical Nurses (RPN) and Personal Support Workers (PSW).
- Demonstrate accountability, effective communication, professionalism, and competency with residents, colleagues, family members and community stakeholders by providing high quality resident care within legislated standards as defined by the Ontario College of Nurses.
- Complete RAI MDS assessments within legislated timeframes set by Ministry of Long-Term Care.
- Facilitate resident care conferences.
- Oversee maintenance of emergency medication system.
- Participate in nursing research, resident satisfaction and continuous quality improvement initiatives.
- Implement a safety culture within area of responsibility by ensuring residents and staff comply with all aspects and regulations related to the Ontario Occupational Health and Safety Act, Fairhaven's Health and Safety policies and procedures as well as other governing bodies.
- Works with Fairhaven's Human Resources department to ensure a fair and appropriate return to work, when employees are off due to illness or injury, and move quickly to resolve any issues related to safety, discipline, workplace violence and harassment.
- Adheres to infection prevention and control program requirements.

QUALIFICATIONS

- Valid RN License from Ontario College of Nurses, or eligibility to obtain a permanent or temporary license
- Long Term Care experience preferred

- Effective interpersonal skills (conflict resolution) organization and multi-tasking skills, while dealing with stressful situations and challenges
- Demonstrate organizational and time management skills
- Demonstrate leadership skills
- Able to fulfill the physical demands of the position
